Belfius Bank SA/NV ("Belfius") announces the launch of a capped tender offer for its outstanding €500,000,000 Undated Deeply Subordinated Additional Tier 1 Fixed Rate Resettable Callable Securities (ISIN: BE0002582600 / Common Code: 176404680) (the "Securities") for cash. Holders of the Securities can find more information in the launch announcement which is available through the following link (the "Launch Announcement").

Concurrently with the tender offer, Belfius intends to issue new Undated Deeply Subordinated Additional Tier 1 Fixed Rate Resettable Callable Securities (the "New Securities"), subject to market conditions.

The maximum acceptance amount of the tender offer is expected to be equal to the aggregate principal amount of the New Securities and will be announced by Belfius after placement of the New Securities.

The purpose of the tender offer in respect of the Securities and of the planned issuance of the New Securities is to proactively manage Belfius' capital structure. The tender offer also provides holders with the opportunity to sell their Securities and apply for priority in the allocation of the New Securities.
